SCRATCH ART - ONE-YEAR LIMITED WARRANTY

WHO IS COVERED

This Limited Warranty applies only to the original consumer purchaser of a new Scratch Art product and is not transferable. Proof of purchase showing the purchase date is required.

WARRANTY PERIOD

Coverage begins on the original retail purchase date and continues for one (1) year.

WHAT IS COVERED

Really Smart Ideas LLC warrants that the Scratch Art product will be free from defects in materials and workmanship under normal indoor residential use during the warranty period.

WHAT WE WILL DO

If a covered defect is confirmed, Really Smart Ideas LLC will, at its option and without charge for the covered remedy: (1) repair the product; (2) replace it with the same or a reasonably equivalent product; or (3) refund the original purchase price. A replacement product or part is covered only for the remainder of the original warranty period.

WHAT IS NOT COVERED
